What is this product?

Type The Company is a Venture Capital closed ended investment company whose shares are listed on the London Stock Exchange main market and is an Alternative Investment Fund under the UK Alternative Investment Fund Directive. The Company's shares are therefore available to the general public.

Objectives The Company's objective is to provide Shareholders with an attractive return from a diversified portfolio of investments, predominantly in the shares of AIM quoted companies, by maintaining a steady flow of dividend distributions to Shareholders from the income as well as capital gains generated by the portfolio.


It is also the objective that the Company should continue to qualify as a Venture Capital Trust so that Shareholders benefit from the taxation advantages that this brings. To achieve this, at least 80% for accounting periods commencing after 6 April 2019 (previously 70%) of the Company's total assets are to be invested in qualifying investments of which 70% by VCT value (30% in respect of investments made before 6 April 2018 from funds raised before 6 April 2011) must be in ordinary shares which carry no preferential rights (save as permitted under VCT rules) to dividends or return of capital and no rights to redemption.

Intended retail investor This product is suitable for sophisticated retail investors or retail investors who have received professional advice and who are UK taxpayers.

Term This product has no maturity date.

What are the risks and what could I get in return?

Risk Indicator

what could affect my return positively?

Investment in a highly diversified portfolio, both by the number of holdings and by sector exposure. Many of the Company's investments are in well-funded businesses which are operating with balance sheets that are sufficiently robust to enable them to successfully navigate an extended period of economic and equity market uncertainty.

what could affect my return negatively?

Investment in early-stage businesses, in which the Company has to invest in order to qualify as a Venture Capital Trust pose a higher degree of risk.

What happens if Unicorn AIM VCT plc is unable to pay out?

The Company is not required to make any payment to you in respect of your investment. As a Shareholder you have no access to the Financial Services Compensation Scheme and would not be able to make a claim to the FSCS about Unicom AIM VCT plc. A default by the Company or any of the underlying holdings could affect the value of your investment. The Company's shares are listed on the London Stock Exchange's main market. Should the Company be liquidated, the amount you receive for your holding will be based on the value of assets available for distribution after all other liabilities have been paid.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

Other relevant information
